These Terms of Service govern access to and use of the websites <https://hardcode.lv> and <https://www.hardcode.lv>, owned by SIA Hard Solutions, registration number 50203698921, VAT number LV50203698921, legal address: Tērbatas iela 68 - 8, Rīga, LV-1001. Contact e-mail: contact@hardcode.lv.

1. General provisions
